

Re: Consumer Information Announcement

Dear Holy Family University Students, Faculty, Staff, Alumni and Families of Students:

The Higher Education Act of 1965, as amended by the Higher Education Opportunity Act of 2008 (HEOA), requires Holy Family University to make available to enrolled students, prospective students, and their parents or legal guardians certain information about its operations. Such information pertains to: (1) general institutional operations and policies; (2) financial assistance (federal grants, loans, state grants, etc.); (3) programs leading to licensure and certification, state information; (4) general completion and graduation rates; (5) annual security report; (6) completion and graduation rates for all students and student athletes; (7) athletic program participation rates and financial support; and (8) Voter Registration information.
