Holy Family University's most recent reaffirmation from MSCHE was in 2021, with its next self-study evaluation scheduled for the 2028-2029 academic year. Below are tentative steps designed to map out Holy Family's course to reaccreditation.

  - Review items needed for self-study design
  - Review tech needs and inform IT
- May 2025 August 2025
  - Consideration of members of self-study steering committee
    - \* Chair and Co-chair for each standard (one faculty, one administrator)
  - Consideration of members of each self-study subcommittee
  - Plan data repository of evidence and narratives
- End of August 2025
  - Final appointment of self-study steering committee
  - Appointment of members of each subcommittee
  - Begin design of Self-study website
- September 2025 (approx.)
  - Self-study Institute
