- · Placements for Telescoped Practicum are limited to specific schools identified by the Field Placement Office.
- Telescoped Practicum requires a minimum of seventy-five (75) hours in the field. Students are scheduled for consecutive full-days in the schools for the period 8:00 am to 4:00 pm.
- A child abuse or criminal record may prevent a student from being placed in a school setting and/or exclude the student from the
 possibility of certification. Failure to disclose any prior arrest or conviction may lead to dismissal from the School of Education.
